USDF-Q = Qualifying class for 2010 GAIG/USDF Championship; state qualifying on entry and add \$10 or will be considered open. J = Juniors / Young Riders only; list birth date on entry; A = Adult Amateur - enclose copy of USEF Amateur card with entry; O = Open; TOC = State level on entry. Freestyles must state level and provide music to announcer at least two hours before scheduled ride time. Any entry not specifying AA, O, JR/YR, A-Q for class will automatically be put in open division. Test of Choice – to include IPEC; FEI tests not offered above, and Young Horse. May be qualifying classes only if correct test is ridden. **Classes Split if entries warrant.**

LEVELS USDF, Intro, Training - Grand Prix. All tests will be current editions.

AWARDS Trophy for classes with 3 or more completed rides and six ribbons for all classes.

USDF/DOVER Adult Amateur Medal

Include legible e-mail address on entry. See page 8 of this book for an entry checklist.

All definitions and rules relating to this show are covered under the General Guidelines on page 5.

Full refund if scratch is received by closing date, less \$20 office fee. **No refunds after closing date or after start of competition.** This includes classes cancelled due to severe weather or other emergency conditions.

Entries are limited on a first come, first served basis. Management reserves the right to add, combine, or divide classes, add or substitute judges, or make any changes required by circumstances. Every class offered herein is covered by the rules and specifications of the current USEF rule book and will be judged and conducted in accordance therewith.

Post Entries will be placed on a waiting list to fill scratches. All "No Shows" that have not contacted the show office prior to first ride will be considered a scratch for the rest of the show and time slots may be filled.

Scheduling Advisory: Any one entering the show riding three horses or more per day does so at their own risk. If show management is not able to schedule the additional rides to the satisfaction of the rider/owner, the entry fees will not be refunded. Show management will try to accommodate you, however.

Please order extra bedding in advance, note number of bales on entry form. No straw can be used for bedding; there will be a \$30.00 fee if straw is used.

Guest Horses are welcome but must send in a completed entry form with all user and office fees, submit a current Coggins, and pay either stabling or day parking.

Make check payable to Spring Fling and mail with entry, negative Coggins, and copies of necessary membership cards to Secretary. Bounced check policy: Void entry and incur a \$30 charge. Entries placed on a waiting list until a money order, certified check, or cash is received.

DIRECTIONS Highfields, 198 Gaston Rd, Aiken, SC 29801. Located less than 1 mile from downtown Aiken. From I-20 take Exit #22 US 1 and follow towards Aiken for approx. 7 miles. At the 2nd light (Sunoco on left and just pass the Bi-Lo on right) turn left onto Hwy 118. Merge right at first light onto Beaufort Street. Follow Beaufort Street almost to the 2nd light and take a left onto Barnwell (State Credit Union on left, street sign only on right). Cross over a dirt road and you will see the Highfield sign and gates. From Richland Ave. in Aiken: Heading East on Richland go past Williamsburg to the next stop light. Take a left onto Beaufort St at the Dollar General. Take the first right (before the Credit Union) onto Barnwell. Highfields is straight ahead.

ARENAS 3 all weather 20m x 60m rings, large grass field. Additional rings and warm-up on grass polo field.

HOSPITALITY Concession on site.
